WHAT IS THE KRA?

THE Kingswood Residents' Association (KRA) is a non-political, non-commercial and voluntary organisation whose aim is the stewardship of the character of the village and whose formally stated objective is *'the promotion of the welfare of the community through the good governance of the district in relation to planning, environment, safety and conservation so as to preserve and improve the amenities of the village'*.

The Kingswood Residents' Association (KRA) is separate from the Kingswood Village Community Association (KVCA) and also separate from the individual private road-owning companies, KHCL and KNECL, and other individual road associations, which have their own aims and objectives.

The KRA works closely with Reigate and Banstead Borough Council (R&BBC) through its borough councillors and also with our local county councillor on matters governed by Surrey County Council (SCC).

The KRA aims to work for the community as a whole, and so all Kingswood residents are welcome to attend our Annual General Meeting. Only members can vote on formal association business and propose a resolution to be voted on at the AGM.

CHAIR'S REPORT

VALERIE EVANS

AFTER TWO years of virtual communication, we will be delighted to welcome you **in person** to our Annual General Meeting. We have some excellent speakers lined up and it will be an opportunity for us to update you on the activities the KRA has undertaken since we last met.

KINGSWOOD SAFETY NET – During March 2020, with the onset of Covid lockdowns, the KRA and the Kingswood Village Community Association (KVCA) jointly set up the

Kingswood Safety Net (KSN) to assist residents with delivery of groceries and prescription collections, or just to provide a friendly voice on the phone. This was much appreciated and brought the village together through over 90 volunteers and local road groups. The volunteers and infrastructure remain ready, should the need arise again.

The KRA has completed several projects aimed at enhancing our village. These have been made possible only through the generous contributions from Reigate & Banstead Borough Council (R&BBC) via the Community Infrastructure Levy (CIL) and grants. Our sincere thanks to R&BBC for funding and to the KRA team for co-ordinating these projects:

- **Tree planting:** by Spring this year a total of 26 new trees will have been planted in Waterhouse Lane, from the Village Hall towards the A217 to enhance the approach.
- **Kingswood village gateway signs:** three new 'Welcome to Kingswood' signs have been installed on Waterhouse Lane, Outwood Lane and Bonsor Drive.
- **Kingswood village website upgrade:** with a grant from R&BBC and assistance from our local councillors, we have updated the website to accommodate mobile devices.

POPPY APPEAL - Through the generosity of residents and businesses, we raised over £3,000 for the Royal British Legion during the KRA's poppy appeals in 2020 and 2021.

LITTER PICKERS - the KRA contributed £200 towards the purchase of gloves and equipment and several KRA committee members are active participants.

STATION SITE DEVELOPMENT - In March 2021 a planning application for 28 flats and a Co-op store was submitted to R&BBC. The KRA held meetings with the developer and the Co-op to register our concerns. We considered it important that residents' views should also be sought, so the KRA sent a flyer to every home to provide a link to the planning portal for residents to record their own comments. 245 comments were submitted (218 objections and 26 in support). In September 2021, the KRA received notification from R&BBC that the planning application had been withdrawn in favour of a previously approved application for 18 houses which the KRA had supported. Our thanks to Keith Denyer of the KRA and to all residents who registered their views to achieve this result.

INSPIRED VILLAGES RETIREMENT VILLAGE - In September 2020, the Inspired Villages (IV) planning application for the redevelopment of the Legal & General site was approved by R&BBC. This application was fully supported by the KRA, who had negotiated with IV over 18 months to address successfully the concerns of both residents and the KRA itself. As part of these negotiations, the KRA secured with L&G, a legally binding covenant to prevent, in perpetuity, further development of the open-space land. The KRA has recently met with IV and L&G and a further update is expected imminently.

RETHINKING KRA STRATEGY - Covid-19 restrictions provided the committee time for some introspection to consider what the KRA currently does and if its activities can be improved. After initial investigation, the committee has endorsed the setting-up of a Strategy Working Group (SWG) to analyse its current activities and to make recommendations.

- The SWG will consider whether the KRA's current remit remains relevant to future demands and if additional services should be considered.
- We will consider the organisation structure to best deliver our services.
- A questionnaire will be sent to all residents this summer to seek your views on the KRA, as we welcome your opinions.

HON. OFFICER FOR PLANNING, JOHN LANG - It is with considerable regret that we announce John Lang's retirement from the KRA committee and as KRA Planning Officer. John became a member of the KRA shortly after moving into Kingswood in 1979 and in the year 2000 joined the KRA's committee on planning, becoming its Chair in 2008. John also represented the KRA as a member of the Banstead Federation of Residents Associations. Planning Officer (North) Keith Denyer is seeking to retire when a replacement is found.

KRA CHAIR – In January 2022 I advised the committee that I would be standing down as Chair at the AGM. I am delighted to advise that David Floyd has offered to become my successor. David has been a committee member for 12 years and has previously served as the KRA's Honorary Secretary. As a member of the current Strategy Working Group, he is ideally placed to steer the KRA through what is going to be a very important period.

We very much hope to meet many of you at the KRA AGM 2022. In the meantime, please continue to be vigilant, and keep safe.

PLANNING

GENERALLY, approval or refusal of planning applications by Reigate and Banstead Borough Council has slowed down due to ongoing Covid conditions. Likewise, appeals to the Inspectorate can now take six months or more. The start of work on the approved Continuing Care Retirement Community at the L&G site has been delayed due to Covid and uncertainties as to when market conditions will return to normal. This information was provided by L&G Capital at a meeting on February 1. Another meeting is planned before our AGM.

The planning application for 28 flats and a shop retail unit in the Kingswood station yard has been withdrawn and the developer appears to be reverting to its earlier application for 18 dwellings without any shop. More details on planning applications can be found under the Kingswood Planning page on the KRA section of the village website www.kingswoodvillage.org

The Government's proposed planning reforms are expected soon. These were due to go before Parliament last year but have been delayed - this in conjunction with a change in Housing Secretary. The intent was, and presumably still is, to speed up the planning process and housing numbers among other things. A Surrey 'Area of Natural Beauty' Boundary Review is in progress, but submissions of views closed at the end of January.

Along with 12 other local residents' associations, we continue to work together as the Banstead and District Federation of Residents' Associations, meeting some four times a year on matters of wider concern, such as national and regional planning policy, borough-wide amenities and the protection of Green Belt land. One of the subjects of concern has been the ongoing finance and existence of the Banstead Commons Conservators. Having lost funding from the EU, RBBC has recently committed to funding for at least another year. PLANNING STRATEGY

JUSTUS VAN DER SPUY

THE KRA justly prides itself on the above team of planning officers who diligently and ably comment on a wide range of planning applications, covering everything from individual homes to major projects such as the station yard development and the redevelopment of the L&G site by IV.

The KRA's planning team also weighs applications in the context of Kingswood's Residential Area of Special Character status; the Conservation Area status of parts of the village; new national planning laws; the 2019 Reigate and Banstead Borough Council Development Management Plan (DMP) and new and evolving planning laws and guidance in relation to the environmental impact of construction activity.

Residents and the KRA have become increasingly concerned by seemingly inconsistent planning outcomes in Kingswood with (often retrospective) planning approvals being secured through appeals allowed by the unelected and largely unaccountable Planning Inspectorate. KRA commentary on a few of the more extreme examples is a matter of record.

There was a growing feeling that something had to be done to get ahead of the curve and influence the planning framework and outcomes for Kingswood. A KRA Planning Strategy Team (PST) was formed and as part of preparing the KRA's detailed response to the Government's Planning White Paper, the PST reviewed the mechanism of Neighbourhood Plans (NP) – highly-structured, consultative processes in which the local council and residents collaborate to help define the planning criteria for their neighbourhoods.

Such plans, if supported by a majority vote in a residential referendum, give councils, and particularly the Planning Inspectorate, clearer criteria for assessing planning applications and appeals. We consulted with other Neighbourhood Forums (NF) in the South-East to learn of their experiences in devising and bringing to referendum their local NP. All spoke of a lengthy, intellectually challenging but rewarding path in which they felt more secure in the adoption of their NP.

We tabled proposals to the KRA during 2021, the essence of which was that the KRA should, without obliging itself to become a NF take steps to seed the formation of a NF and thereby support the first tentative steps required to determine what prospects or opportunities such a plan might hold for Kingswood. The KRA declined to pursue this opportunity and that outcome will be considered in the context of the recently commenced KRA strategic review.

Finally, I would like to thank Bruce Noble for his research, critical thinking and sheer outright effort as a member of the KRA's Planning Strategy Team.



ROADS & TRANSPORT

MIKE GIBSON

RAILWAY SERVICE – This has continued to be plagued by reductions, largely due to Covid 19. Staff availability has been very poor and training of new staff has suffered. Hopefully, we will start to see improvements as the pandemic recedes.

ROAD WORKS – A continuing issue, but there have been no major problems in the last year. I continue to monitor the available advance information and issue frequent emails to warn of work on the main roads. To avoid sending too many emails to everyone, any instances of work involving carriageway closures in residential roads are notified to the relevant committee member for local transmission.

NEW VILLAGE SIGNS – These have been installed on the three main entry roads to the village. They have been positioned where Surrey Highways have approved and two had to be installed by contractors for Surrey Highways. They are not at our boundary, largely because of who owns the verges at the different locations. These signs were an initiative of Kingswood Residents' Association and funded by Reigate and Banstead Borough Council (R&BBC) from the Community Infrastructure Levy (CIL) on developers, with our thanks.

NEW TREES – These have been planted on Waterhouse Lane with more due soon - another KRA initiative funded by R&BBC from the CIL.

ROAD SAFETY – One such initiative has resulted in a survey of speed on Outwood Lane following a petition by residents near the viaduct. The results found that the speeds were not in excess of the speed limit. However, the petitioner was unaware of the width restriction - designed to prevent large lorries using this stretch of road - and its lack of enforcement, which I think is the main problem there. As a result, this was not considered in the survey. I have asked for the enforcement of that limit to be actioned.

PARKING IN THE VILLAGE – Always a problem and it is becoming more so now that life is slowly returning to normal. Enforcement has been lacking but the poor bay markings haven't helped. I am hoping that some additional parking might be allowed once the redevelopment of the retirement village on the former L&G site is completed.

SPEEDING PAST THE SHOPS – Another regular problem; this is an issue because of the narrowness of Waterhouse Lane and parking on both sides. I have tabled some suggestions for consideration by the committee.

YOUR BOROUGH COUNCILLORS

MESSAGE FROM COUNCILLORS PARNALL, NEAME & ARCHER

THE LAST year, as the previous year, has been dominated by the Covid-19 pandemic and the measures we have taken as individuals and as a community to look after each other. Just as we thought we were coming out of the crisis, the Omicron variant struck, and we were forced to be cautious again.

Throughout the pandemic, councils have been at the heart of the government's support network for businesses, and Reigate and Banstead Borough Council has supported businesses, shops and nurseries through grants and Business Rates Relief.

As councillors we are tremendously proud of the heroes of our community - the national award-winning litter pickers who have transformed our environment for example - and we are also proud of our officers who have continued to provide support for hundreds of isolated and lonely residents.

Over the last year, recognising local need, the council has both fully financed and supported housing projects across the borough. This includes 25 homes in Preston - a mixture of one- and two-bedroom apartments and family houses. Of these, six went to 'help to buy' and eleven for 'shared ownership'. We are just completing building in Cromwell Road, Redhill, adding another 32 properties to the affordable/social housing rental market. We are in the process of building four unique individual properties for residents with special needs in Horley, and we plan to increase our emergency and temporary accommodation.

Last year we reported there had been a rapid (and perhaps surprising) growth in planning applications – 1,417 across the borough, the highest number since 2017. This trend has continued into 2022. Many of these are household extensions as people adapt their properties to enable them to work at home. Taken alongside government relaxations, such as that on construction hours, there has also been a large increase in enforcement activity, certainly of reports requiring investigation, often because people locked down and working at home are more able to observe development in progress.

As we emerge from the pandemic, we do so with a five-year plan which puts a prudent emphasis on sustainability and the environment. Last September, after public consultation, the council adopted a Supplementary Planning Document (SPD) on Climate Change and Sustainable Construction which gives very real and practical measures that can and should be applied to new construction projects.

We have also provided funding for many local projects through the Community Infrastructure Levy (CIL) that we impose on development. You will be aware of the new trees in Waterhouse Lane and the three new village entrance signs. Special thanks are due to Adrienne Light who proposed and led these projects for the KRA. This year we are hoping to replace the bins in the village with black and gold bins which will be more in keeping with the area, and we're keen to hear from any resident who has an idea for what we can do to further improve our shared public space.

YOUR COUNTY COUNCILLOR

MESSAGE FROM COUNCILLOR REBECCA PAUL

TIME HAS flown and I now find myself ten months into the role of county councillor for Tadworth, Walton and Kingswood. And what a privilege it has been to represent you all and to learn even more about this wonderful area we all call home.

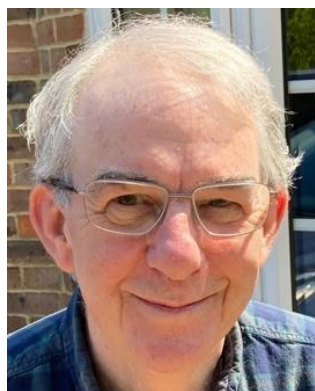
Over recent months I have been involved in several projects in Kingswood. The most significant has been the drainage improvement works undertaken on Bonsor Drive, which involved the installation of six new gullies and the connection of two previously-unknown soakaways. This was a significant piece of work and initial feedback on the impact on drainage appears promising. You'll also be reassured to hear that the pavement along Bonsor Drive is now recognised by Surrey Highways as needing improvement work, although there is no timeframe for this as yet.

Other projects underway include the assessment of Waterhouse Lane and Outwood Lane for speeding problems, with the aim being to consider whether these roads would benefit from traffic calming measures. I will, of course, keep you updated on these discussions as they progress.

Hopefully, you have all heard about my fairer road funding campaign which I launched last December. The purpose of this is to raise the issue of road funding allocation with the Government in Westminster. Currently the funding formula only considers road length and doesn't take into account traffic volume. This results in busy road networks like Surrey's not receiving sufficient funding to address wear and tear. I've currently got over 2,000 signatures on the petition, but many more are needed to secure the necessary parliamentary debate.

I am also delighted to say that, from the end of November, I have been appointed to the Surrey County Council Cabinet with responsibility for Surrey's levelling-up agenda. It's incredibly important that levelling-up includes Surrey and I intend to make sure our needs are communicated to Government and we are not overlooked. As a major contributor to UK Gross Value Added (GVA) – a measure of the contribution to the economy of each individual producer, industry or sector - and one of the few areas of the UK that generates a net fiscal surplus, it's vital that Surrey receives the investment needed to remain prosperous. I am very happy to share with you my work on the levelling-up agenda at a future meeting if that would be of interest.

And finally, it's just left for me to say thank you to the Kingswood Residents' Association and the residents of Kingswood. It has been a pleasure working with you all on the aforementioned projects. Please don't hesitate to contact me if you need my help with anything.
